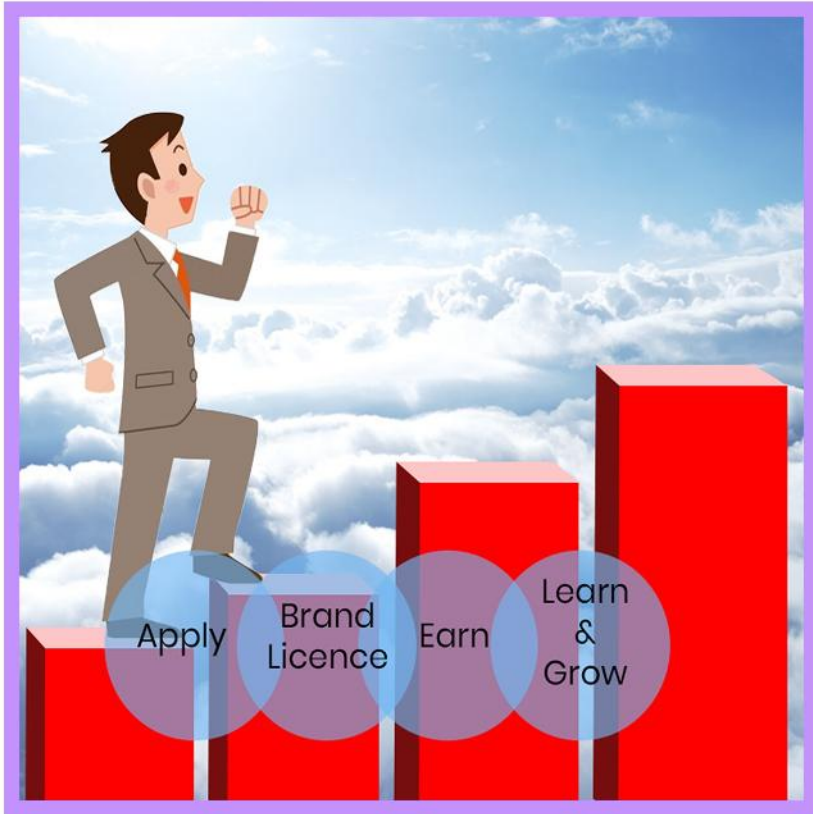

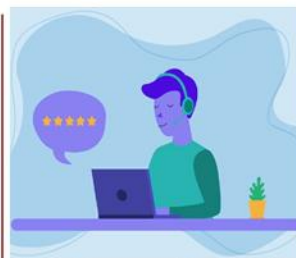
How Franchise Business Works

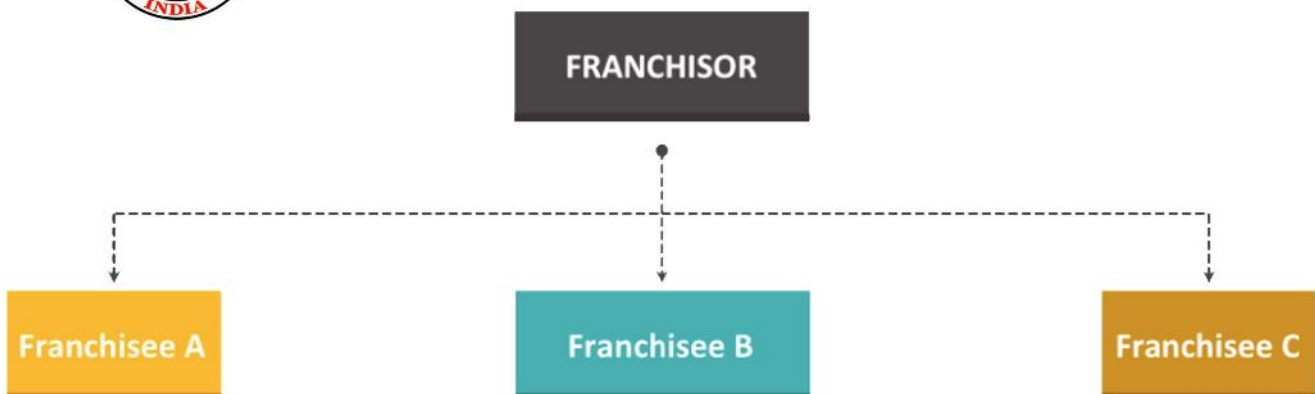
